FOREWORD

The budget is a legal instrument for the delivery of government's intentions to its people. The budget document, and by extension the annual audit report of government, are really 'the people's documents'. They are meant to provide a binding statement of intent and an accountability instrument to citizens of government's stewardship.

Often though, these documents are long, convoluted and complicated to understand. They do not lend themselves easily to lay readers. It is imperative though that citizens have access to this information in a clear and intelligible manner. This will increase understanding, promote engagement, encourage greater citizen monitoring, and provide information that engenders informed and incisive questioning – all aimed at improving the budget process and budget performance. This will in turn improve government performance, increase effective service delivery, and strengthen the trust between citizens and the state that deepen our democratic process and entrench accountable governance processes.

A key component of the budget is the Capital Budget – which provides the resources to achieve key existing, on-going as well as new projects. Through a greater understanding of this, citizens are better able to see how government's resources are being deployed, advocate for the completion of abandoned capital projects and support the process of avoiding duplication, as well as connect with the tangible efforts of government to deliver services.

Centre for Social Justice (CSJ) began in 2010 the laudable process of generating a Capital Budget Pullout from the Health Sector (especially as it relates to activities that will improve Maternal, New Born and Child Health (MNCH) and enable Nigeria meets its commitments to the SDGs) for use by the general public.

This simple pull-out is a great aid that covers a number of Ministries, Departments, and Agencies (MDAs) whose mandate covers issues impacting on MNCH outcomes for Nigerians. The Strengthening Advocacy and Civic Engagement Project (USAID Civil Society Project) supports the MNCH Cluster (led by CSJ) and welcomes the deepening of processes linked with increasing the availability of readily-digestible information that improves the informed engagement of citizens and civil society in the process of understanding, engaging with and monitoring budget processes in order to improve transparency, accountability and good governance in Nigeria.

We strongly recommend this 2016 MNCH Capital Budget Pull-Out as a key reader for the range of interested actors at local, state and federal levels who wish to engage responsibly in the budget. We congratulate CSJ for its diligence and work in providing this detailed and holistic breakdown. Also, we strongly hope that this contributes to improving the use of resources and, ultimately, access to improved MNCH services for all Nigerians, especially the women and girls who have a dire need to benefit from this.

The total capital budget provision for MNCH in the 2016 Federal Budget is NGN17,745,868,584.00 (Seventeen Billion, Seven Hundred and Forty five Million, Eight Hundred and Sixty Eight Thousand, Five hundred and Eighty Four Naira) only. However, there are un-disaggregated provisions in Service Wide Votes for SDGs which may include sums for MNCH provisioning. There are also provisions made by donors for MNCH which are not disclosed in the budget.

If 25 percent of the SDGs sum is dedicated to MNCH, it will amount to N8,504,207,318. When this is added to the original N17.745bn, it will come up to N26, 250, 075, 902 (Twenty Six Billion, Two Hundred and Fifty Million, Seventy Five Thousand, Nine Hundred and Two Naira).
