### **ACKNOWLEDGEMENT**

Centre for Social Justice (CSJ) acknowledges the hard work and dedication of its staff in the compilation of this pull-out.

#### Introduction

Nigeria is going through an economic and fiscal crisis where its retained revenue simply pays for debt service and the bulk of the resources required for personnel, overhead and capital expenditure is borrowed. The revenues are simply inadequate to fund fundamental expenditure. Therefore, every available fund should be spent with the greatest value for money, tied to a high-level national policy framework and aimed at improving livelihoods, growing the economy, reducing poverty and inequality, adding value, etc. It is against this background that the pullout of frivolous, inappropriate, unclear and wasteful expenditure calls the attention of the executive, legislature, private sector, civil society including the media to these frivolities at a time of grave national crisis.

According to the 2022 Budget Call Circular, resources are to be allocated based on actual needs, in line with the immediate needs of the country as well as government's developmental objectives and priorities. Starting from the Presidency's State House Headquarters, the pullout calls on the leadership to lead by example. Spending billions of naira every year on routine maintenance of State House facilities is a huge waste. All statutory transfers are stated as lump sum provisions without details. No person, government agency or organization has the right in a constitutional democracy to spend public funds in a way and manner that is unknown to the ultimate sovereigns, being the tax payers and citizens. There is no law authorizing this kind of budgeting. It is unconstitutional, illegal, unethical, inappropriate, etc. The details should be provided to Nigerians. The National Assembly (NASS) is called upon to review its estimates and reduce same by not less than 25% to free up resources for other importantneeds of the economy. This will amount to an allocation of N100.5billion and savings of N35.5bn.

The lust for big vehicles is demonstrated by the News Agency of Nigeria which voted N82million for "purchase of SUV jeep for chief executive/managing director". FGN is still funding agencies for Muslim and Christian pilgrimages at a time of lean resources. The votes of the Ministry of Agriculture are suffused with vague, unclear bulk provisions for activities without locations which have no clear deliverables. NASS should insist on the details and these details should be written into the estimates before approval. This vague budgeting has been the practice over the years and the central poser is; where is the factual evidence of improvements in livelihoods, increase in crop and animal production and value addition to the commodities after years of hundreds of billions of investments in the sector?

The word "empowerment" has been elevated to a magical status and all that needs to be done is to add "empowerment" to budgetary provisions and it acquires a new problem-solving status. Specificity in allocations is imperative for the improvement of the status of the poor and vulnerable groups. This will raise and provide answers to posers such as; what exactly are we targeting? Is the proposedvote the best approach to solve the problem or what alternatives exist? Playing on words and providing estimates for the same activity under different names is the norm in so many MDAs.

The meagre resources allocated to Works and Housing has been so thinly spread across hundreds of projects to the extent that money will be spent without any concrete improvements in the road or housing stock. In the interim, NASS should prune down the number of projects and focus on a few which can be improved upon from available resources. Otherwise, voting N100m, N200m to major road projects (even when prudently spent) will amount to a waste of resources.

The provision of over N260billion in Service Wide Votes for special interventions and poverty reduction is worrisome. Over the years, there is no evidence of benefits to the population accruing from these votes. But the authorities insist on continuing a practice without visible benefits. Several programmes in many MDAs have received multi-year funding for skill acquisition and employment creation. It is imperative to demand for reports of achievements in terms of outputs and outcomes and the value for money statement of previous investments. Otherwise, this is a waste of public resources. When you compare the level of unemployment and the votes in several MDAs in previous years, it will be clear that either this kind of votes have been mismanaged or have not been invested as proposed. There are no locations and identifiable class of beneficiaries in so many projects in MDAs including Niger Delta, Labour and Productivity, Water Resources, etc. The proposed beneficiaries are at large and so wide and there are no decipherable selection criteria considering that the requested amount cannot go round all persons belonging to these generic groups. NASS should insist on locations, qualification criteria of proposed beneficiaries and reports of previous achievements.

The 12 River Basin Development Authorities sit on thousands of acres of public land. For instance, the estimate of N50m was requested for clearing of the 5,000ha farmland in Auchi, Edo State by the Benin Owena RBDA. They get allocations for tractors, farm equipment, implements, fish and livestock replenishment, seeds, processing machinery and implements, etc. RBDAs should be revenue centres that remit hundreds of billions of Naira to FGN instead of the current approach where they gulp money without any meaningful contribution to the revenue. At a minimum, RBDAs should be compelled to fund their personnel and recurrent expenditure pending when they are fully weaned of public funding.

#### FEDERAL MINISTRY OF POWER -HQTRS AND NATIONAL RURAL ELECTRIFICATION AGENCY

The continued public funding of distribution and rural electrification projects is of doubtful legal validity considering the privatisation of the distribution sub part of the electricity value chain. The scenario is like this: FGN through the Ministry and National Rural Electrification Agency invests heavily in distribution infrastructure and extending electricity to rural areas including providing/replacing transformers and as soon as this is done, the DISCOs move in to start collection of tariffs. A clear case of DISCOs reaping where they did not sow. Even if FGN still partly owns the DISCOs, it should take inventory of its commitments post privatisation and factor it into the ownership structure and profits of the DISCOs. There is a contradiction in continued investment of public money for private profits, especially when the bulk of the funds are borrowed.

#### FEDERAL MINISTRY OF WORKS AND HOUSING

The meagre resources allocated to these two critical sectors rolled into one (works and housing) has been so thinly spread across hundreds of projects to the extent that money will be spent without any concrete improvements in the road or housing stock. In the interim, NASS should prune down the number of projects and focus on a few which can be improved from available resources. Otherwise, voting N100m, N200m to major road projects (even when prudently spent) will amount to a waste of resources.

Considering the enormous work and resources required in works and housing, it may be imperative to separate the Ministry of Works and Housing into two separate ministries, one for Works and the other for Housing. In Works, road sector financing can be improved through a Road Fund and Road Management Authority Act that will raise funds from a plethora of sources including toll gates, special surcharge on some commodities, etc. Also, there is need to establish special purpose vehicles to garner and aggregate resources from institutional and retail investors for investments in the sector. For Housing, re-organise the National Housing Fund and mobilise funds for the benefit of contributors over the short, medium and long

Finally, the massive number of roads with votes for rehabilitation, repairs, etc., shows that either there is no performance or quality standards to be met by contractors in road construction or that the standards are observed in the breach. Road construction should be based on specifications that ought to be met before the contractor is paid, express warranties and an agreement on the number of months/periods the road will last before maintenance services. Virtually all federal roads are undergoing maintenance including roads that are less than two years old.
