This Bill seeks to strengthen the operations of the Office of the Auditor-General for the Federation by placing its funding on the first line charge of the Consolidated Revenue Fund of the Federation. The Bill also seeks to empower the Auditor-General for the Federation and the Auditor-General of State Governments to directly audit the accounts of government statutory Corporations.
