- Order directing the president to ensure that the overall limits for amounts of consolidated debt of the Federal, State and Local Governments in Nigeria is set, approved and enforced in line with Section 42 (1) of the Fiscal Responsibility Act 2007.
- The Case came up on 22nd April, 2014 for hearing, but court did not sit because of Easter break. Case adjourned to July 16, 2014.

 Order of mandamus compelling the Respondent to make available to the Applicant detailed information of the contract awarded sometime in April 2013 to Elbit Systems, a company based in Haifa, Israel for the supply of the Wise Intelligence Technology System for intelligence Analysis and Cyber Defence for Nigeria.

Case heard and leave refused. Appealed and records transmitted Court of Appeal. Appellants brief of argument filed and waiting date for hearing.

- Order of mandamus compelling the Respondent to grant to Applicant access to details of salaries and emoluments of civil servants as distinct from political office holders
